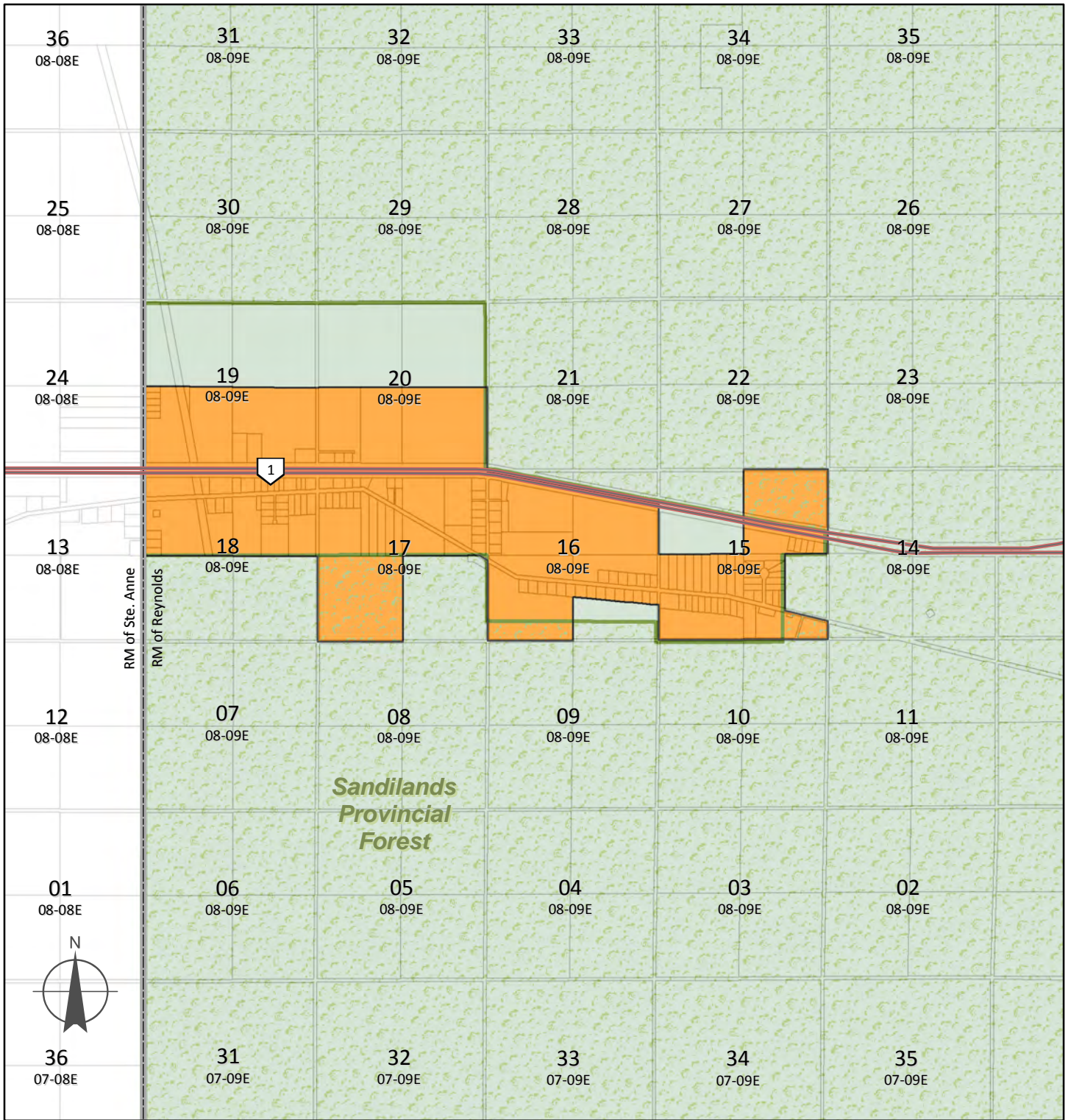

Map 7 - Richer-East

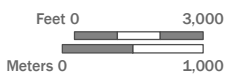
